There will be a \$20.00 charge on all return checks. Costs of collection agency fees, legal fees, interest and service charges will be added to all unpaid invoices if litigation is necessary for collection. Freight charges will be added to each order.

All claims must be made within 30 days of shipping date. Returns must have written authorization from Eurocomponents, Inc.; no returns without authorization will be accepted. A 20% handling fee will be charged to restock parts. The 20% handling fee will not be charged if the return is the result of defective merchandise or an error on our part. All returns must be sent freight prepaid and packaged correctly; customer is responsible for products damaged during shipment due to improper packaging. Absolutely no packages will be accepted for return if shipped C.O.D to us. Eurocomponents, Inc. will release a credit for the returned merchandise at the price of purchase for future orders.
